## Alfred G. Feliu

Feliu, PLLC, following the merger of Vandenberg & Feliu with Michelman & Robinson.

Mr. Feliu's legal advice is rooted in his wealth of experience from a multitude of perspectives - as counsel to management and individuals, as a neutral mediating disputes and resolving them as an arbitrator, and investigating such disputes as an independent investigator.
